

LEISURE IN AGRITURISM FARM AGREEMENT

Agreement entered into on in by and between Karolina and Witold Smolenscy – Agriturismo Farm in Srednie Male 1, 38-709 Polana, tel. 00480505092774, 00480501286628, hereinafter referred to as „Hosts”, and residing in (exact address and zip code)

Tel. - parents (guardians) of the child (full name) born on in Child's personal identity number State health-insurance fund name E-mail

The subject matter of this agreement is child's leisure at Hosts – on terms provided hereunder:

1. The term of leisure -

Another term agreed

2. The parents state that they are familiar with the terms of the leisure offered to them by Hosts on their agriturismo farm and they agree to them.

3. The parents place the child in Hosts care during the term of leisure and Hosts state that they take on this care and shall perform it duly.

4. The parents agree that their child take part in bareback riding, conducted by qualified instructors and by mountain riding tourism leaders in „Srednie” Hucul pony stud farm and that their child take part in other events organized by Hosts or taking place around with Hosts participation.

5. Should the child be seen to it that they attend Sunday masses?

6. Do the parents contract the organizer to transport the child from and to Warsaw for 220.00 zlotys altogether for a return ticket (110 zlotys single) or do they transport by themselves?

7. The parties establish the fee for: two-week child's stay on the farm for 1220.00 zlotys (say one thousand two hundred and twenty zlotys), including the travel – 1440.00 zlotys (say one thousand four hundred and forty zlotys), including a full range of services stipulated by the agreement. The confirmation of concluding of the agreement shall be the payment of deposit of 25 per cent – i.e. 300 zlotys in case of a camp without the transport or 360 zlotys in case of a camp with the transport on the account hereunder.

The remaining part should be paid by the parents two weeks before their child's arrival on the account: **Karolina Smolenska Bieszczadzki Bank Spółdzielczy w Ustrzykach Dolnych**

(Karolina Smolenska Bieszczady Cooperative Bank in Ustrzyki Dolne) 58 8621 0007 2001 0002 6622 0001. In case of resignation from the leisure not by fault of Hosts – they return the paid sum to the parents reduced by the deposit (300.00 or 360.00 zlotys).

8. Hosts state that they cooperate with a paediatrician, which guarantees medical care during the child's leisure.
9. For the time of the leisure the child shall bring their student card, a proof of insurance, a personal identity number, personal belongings, a raincoat, wellington boots, a torch and a sleeping bag.
